Description	A monthly cash settled future based on the ICE SYN (Light Sweet Synthetic Crude) Monthly Volume Weighted Average Price Index (ICE SYN 1a). The ICE SYN 1a Index is expressed as a differential to the NYMEX WTI 1st Line Future (Calendar Month Average)

Contract Size	1,000 barrels
Unit of Trading	Any multiple of 1,000 barrels
Currency	US Dollars and cents
Trading Price Quotation	One cent (\$0.01) per barrel
Settlement Price Quotation	One hundredth of one cent (\$0.0001) per barrel
Minimum Price Fluctuation	One hundredth of one cent (\$0.0001) per barrel
Last Trading Day	Trading shall cease one Canadian business day prior to the Notice of Shipments (NOS) date on the Enbridge Pipeline. The NOS date occurs on or about the 20th calendar day of the month, subject to confirmation by Enbridge Pipeline. The official schedule for the NOS dates will be made publicly available by Enbridge Pipeline prior to the start of each year.

Floating Price	<p>In respect of daily settlement, the Floating Price will be the volume-weighted average of the ICE SYN 1a Index for each trading day during the same period, as published by ICE-NGX.</p> <p>For forward months, the Floating Price will be determined by ICE using price data from a number of sources including spot, forward and derivative markets for both physical and financial products</p>
Final Settlement	<p>A price in USD and cents per barrel based on the ICE SYN 1a Index, as published by ICE-NGX. The index pricing period begins on the first Canadian business day of the calendar month prior to the contract month and ends on the Canadian business day prior to the NOS date (as published by Enbridge) in the same calendar month</p>
Contract Series	<p>Up to 60 consecutive months</p>
Final Payment Date	<p>Two Clearing House Business Days following the Last Trading Day</p>
Business Days	<p>Publication days for ICE-NGX Crude Oil Markets</p>
