In respect of final settlement, the Floating Price will be a price in USD and cents per barrel based on the difference between the average of the “Mid” quotations appearing in the “Platts Asia-Pacific/Arab Gulf Marketscan” under the heading “Singapore” subheading “FOB Singapore (\$/barrel)” for “Kerosene” and the average of the “Mid” quotations appearing in the Platts “Crude Oil Marketwire” under the heading “Key Benchmarks (\$/barrel)” for “Dubai” prompt month for each business day (as specified below) in the determination period.
