Floating Price	In respect of daily settlement, the Floating Price will be determined by ICE using price data from a number of sources including spot, forward and derivative markets for both physical and financial products.

Final Settlement	In respect of final settlement, the Floating Price will be a price in USD and cents per barrel based on the difference between the average of the "Mid" quotations appearing in the "Platts Asia-Pacific/Arab Gulf Marketscan" under the heading "Singapore" subheading "FOB Singapore (\$/barrel)" for "Gasoil" and the average of the "Mid" quotations appearing in "Platts Crude Oil Marketwire" under the heading "Key Benchmarks (\$/barrel)" for "Dubai" prompt month for each business day (as specified below) in the determination period.
