Last Trading Day	The last Business Day prior to the Contract Period

# Contract Specifications

a) Ref Price A - Description	"ELECTRICITY-MISO-MINNESOTA HUB-DAY AHEAD" means that the price for a Pricing Date will be that day's Specified Price per MWh of electricity for delivery on the Delivery Date, stated in U.S. Dollars, published by MISO at <a href="https://www.midwestiso.org/Library/MarketReports/Pages/MarketReports.aspx">https://www.midwestiso.org/Library/MarketReports/Pages/MarketReports.aspx</a> , under the headings "Library: Market Reports" or any successor headings, that reports prices effective on that Pricing Date.
b) Ref Price A - Pricing Date	Each day that prices are reported for the Delivery Date
c) Ref Price A - Specified Price	The average of LMPs for all hours, EST, that are not ending 0800-2300 EPT
d) Ref Price A - Pricing calendar	MISO
e) Ref Price A - Delivery Date	Contract Period
Final Payment Date	The Third Clearing Organization business day following the Last Trading Day
