Strike Price Intervals	Strike Price Listing Provisions: A minimum of 10 Strike Prices in increments of \$0.25 per MMBtu above and below the at-the-money Strike Price. Strike Price boundaries are adjusted according to futures price movements. User-defined Strike Prices are allowed in \$0.001 increments.

	Manual exercise or abandon is not permitted
Exercise Procedure	Options which are "in the money", with respect to Reference Price A, exercise automatically into the Underlying Futures Contract with a contract price equal to the Strike Price. Options which are "out of the money" expire automatically.
	Exercise Day: The second Clearing Organization business day following the Last Trading Day
Listing Cycle	Up to 60 consecutive monthly Contract Periods, or as otherwise determined by the Exchange.
Last Trading Day	At the end of the Trading Session on the last Business Day prior to the first calendar day of the Contract Period.

a) Ref Price A - Description	"NATURAL GAS-APPALACHIA (EASTERN GAS - APPALACHIA)-INSIDE FERC" means that the price for a Pricing Date will be that day's Specified Price per MMBTU of natural gas for delivery on the Delivery Date, stated in U.S. Dollars, published under the heading "Monthly Bidweek Spot Gas Prices (\$/MMBtu): Appalachia: Eastern Gas, Appalachia : Index" in the issue of Inside FERC that reports prices effective on that Pricing Date.
b) Ref Price A - Pricing Date	First publication date of the Contract Period
c) Ref Price A - Specified Price	Index
d) Ref Price A - Pricing calendar	Inside FERC
e) Ref Price A - Delivery Date	Contract Period
