Listing Cycle	Up to 365 consecutive daily Contract Periods, or as otherwise determined by the Exchange
Last Trading Day	The Business Day prior to the Contract Period
Final Settlement	Reference Price A
REFERENCE PRICE A	ELECTRICITY-PJM-BGE-REAL TIME

a) Ref Price A - Description	"ELECTRICITY-PJM-BGE ZONE-REAL TIME" means that the price for a Pricing Date will be that day's Specified Price per MWh of electricity for delivery on the Delivery Date, stated in U.S. Dollars, published by the PJM at http://dataminer2.pjm.com/feed/rt_hrl_Imps/definition under the headings "Locational Marginal Prices: Real-Time Hourly LMPs: BGE" or any successor headings, that reports prices effective on that Pricing Date.
b) Ref Price A - Pricing Date	Each day that prices are reported for the Delivery Date
c) Ref Price A - Specified Price	Average of LMPs for all hours ending 0100-0700, 2400 EPT
d) Ref Price A - Pricing calendar	РЈМ
e) Ref Price A - Delivery Date	Contract Period
Final Payment Date	The second Clearing Organization business day following the Last Trading Day
