# Contract Specifications

a) Ref Price A - Description	"ELECTRICITY-MID C OFF-PEAK-ICE" means that the price for a Pricing Date will be that day's Specified Price per MWH of on-Off-Peak electricity for delivery on the Delivery Date, stated in U.S. Dollars, published by ICE at <a href="http://www.theice.com">www.theice.com</a> , under the headings "Day Ahead Power: ICE Daily Indices: Hub: Mid C Off-Peak: Wtd Avg Index" or any successor headings, that reports prices effective on that Pricing Date.
b) Ref Price A - Pricing Date	Each day that prices are reported for the Delivery Date
c) Ref Price A - Specified Price	Avg
d) Ref Price A - Pricing calendar	ICE
e) Ref Price A - Delivery Date	Contract Period
Final Payment Date	The third Clearing Organization business day following the Last Trading Day
