Final Settlement	In respect of final settlement, the Floating Price will be a price in USD and cents per barrel based on the average of the "Mid" quotations appearing in the "Platts Crude Oil Marketwire" report under the heading "North Sea Spot Crude Assessments (\$/barrel)" and "Spread vs fwd Dated Brent" for "Johan Sverdrup" for each business day (as specified below) in the determination period.
