NEW PHYSICAL GAS MARKETS ON ICE

Please be advised that on **Monday April 6** ICE will launch several new physical gas markets, which are detailed below.

1. Transco - River Road

This new market will be defined as 'Transcontinental Pipeline - River Road Interconnect'. 'Transco-River Road' will be available both as a bilateral and an NGX Cleared market.

ICE will list fixed price, physical basis, Gas Daily index and Inside Ferc index markets for this new location.

The 'ID, GDD' and 'ID, IF' markets will anchor off the Platts 'Transco Zone 6 Non-NY North' daily and monthly indexes, respectively.

2. MEP - Lamar

This new market will be defined as 'Midcontinent Express Pipeline - Lamar, Oklahoma'. 'MEP-Lamar' will be available as a bilateral-only.

ICE will list fixed price, physical basis, Gas Daily index and Inside Ferc index markets for this new location.

The 'ID, GDD' and 'ID, IF' markets will anchor off the Platts 'NGPL - TxOk' daily and monthly indexes, respectively.

3. Tres Palacios Hub - Injection (GDD only)

This new 'ID, GDD' market will complement the existing suite of fixed price and physical basis products. This market will anchor off the Platts 'East Texas, ICE Tres Palacios Hub - Injection' daily index.

4. Tres Palacios Hub - Withdrawal (GDD only)

This new 'ID, GDD' market will complement the existing suite of fixed price and physical basis products. This market will anchor off the Platts 'East Texas, ICE Tres Palacios Hub - Withdrawal' daily index.
