- 5. Subscriber hereby acknowledges Payor may make payment for Subscriber's applicable charges.
- 6. In the event that this Addendum is terminated, unless Subscriber promptly notifies ICE Data to discontinue the Global Index Feed Data service to Subscriber, the service will continue to be provided to Subscriber, with Subscriber thereafter being fully responsible for prompt payment of all applicable, new charges and past due, unpaid charges.
- 7. In the event Payor simply fails to pay any applicable charge due and outstanding, ICE Data may notify both the Payor and Subscriber.
