FCOJ Futures Daily Price Limit Expands to 20 Cents Per Pound

Effective with the start of trading for trade date Wednesday, April 10, 2024, the Daily Price Limit for all FCOJ futures contract delivery months subject to a limit will expand to 20 cents per pound above and below the prior day Settlement Price for the respective delivery month.
