Reminder: Spot Month Position Limit Dates for Financial, Energy and Digital Asset Contracts

For the June 2026 expiry contracts in Financial and Energy contracts and for spot month Digital Asset, Oil and NGL contracts expiring in May 2026, positions must be in compliance with spot month position limits on and after the compliance date. **Please be reminded that position limits apply on both an inter-day and intra-day basis. This means that positions must be in compliance with spot month position limits as of the close of business on the business day preceding each of the compliance dates listed below.**

Exemptions

Exemptions may be available for bona fide hedging positions, arbitrage, spread or straddle positions or risk management positions in accordance with Rule 6.29. For the Henry Hub LD1 Fixed Price Future, a Conditional Limit is also available in accordance with Rule 6.20. Exemption requests should be submitted no later than five (5) business days prior to the date the position limit takes effect.
