CHANGE IN MARGIN RATES

Summary

This Information Memo notifies Members that NYSE Liffe U.S.'s (the "Exchange") clearing service provider will change customer margin levels effective trade date March 5, 2013.

1.1 Effective trade date March 5, 2013, the Exchange's clearing service provider will change customer margin levels for 100 oz. Gold Futures, 33.2 oz. mini-sized Gold Futures, 5,000 oz. Silver Futures, and 1,000 oz. mini-sized Silver Futures, as well as all the mini MSCI Index Futures. Customer margin rates for all other exchange products are unchanged.
