Effective February 10, 2025

Eligible D4 RIN Generation Facilities

Pursuant to Exchange Rule 19.H.2, which provides the terms and conditions for the D4 RIN Vintage Future (“Contract”), the following are eligible D4 renewable identification number (“RIN”) generation facilities. RINS generated from these facilities are eligible for delivery against the Contract in accordance with Part N.1 of the ICE Clear Europe Delivery Procedures.

The Exchange, at its sole and absolute discretion, may include or exclude any generation facility from this list for any reason. Notice of such action shall be posted by the Exchange and said generation facility will be struck from the official list. The addition or subtraction of a generation facility eligible for delivery shall be binding upon all contract months which have a last trading day that is more than 90 calendar days from the date such generation facility is added to or subtracted from the official list.

Notwithstanding the foregoing, if a generation facility falls into commercial disrepute, as determined at the sole and absolute discretion of the Exchange, the Exchange may remove said generation facility from this list. In such circumstance, the subtraction of a generation facility eligible for delivery shall be immediately binding upon all contract months.
